Brief Scope of Work:

Sumner Meadows Golf Course Pond Drainage – FEMA Project G2

The work covered under this contract shall include the removal of silts deposited at the bottom of 5 ponds located within the Sumner Meadows Golf Course during the November 2006 floods. The work shall include and not be limited to, the removal of silts from approximately 175,000 SF (est. 7,200 CY of silt) of pond area, restoring pond depths back to their original constructed elevation utilizing underwater vacuum system for silt removal and silt bags to contain water and suspended solids, containment of removed silts to other locations on the golf course, cleaning of irrigation intake systems, restoration of fairway greens and golf course facilities back to their original preconstruction condition.
