The City of Sumner is releasing a Small Public Works Project. As a contractor on the Small Works Roster, you are invited to express interest on this project.

PROJECT TITLE: CIP 08-07 2009 Street Chip Seal and Asphalt “Fog” Coating

Description of Work

Chip seal 19,374 sq. yds. of city streets as per 2008 Washington State Standard Specifications; 5-02.3(3) Chip seal aggregate size 3/8-U.S. No. 10, 5-02.3(3) Fog coat, CSS-1 or CSS-1h, application rate to 0.10 to 0.18 diluted gallons per SY.

The contractor shall provide all traffic control and flagging, including 48 hour notification to home and business owners in advance of the work on the streets. The contractor shall place temporary no parking signs that clearly includes the dates and times 48 hours prior to the work.

Cover and protect city utilities such as water valves, sewer lids, storm lids and gas valves, including thermal plastic cross walks and stop bars. Sweeping of streets after the chip seal and before the fog coating is applied.

All work, equipment and materials shall conform to the 2008 Washington State Standard Specifications, and the City of Sumner Standards.
